- (1) The Government of India has received a loan from Japan International Cooperation Agency (JICA) towards the part of the cost of the Mumbai – Ahmedabad High Speed Railway Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for “Construction of PSC Bridge No. GAD 11 over National Highway (NH-48) at MAHSR Km 241.640, Navsari district, Gujarat on Project for the Development of Mumbai-Ahmedabad High Speed Rail”.
- (2) Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans and is open to all Bidders from eligible source countries, as mentioned in Section-V Eligible Source Countries of Japanese ODA Loans.
- (3) The Government of India through National High Speed Rail Corporation Limited (NHSRCL) now invites sealed Bids from eligible Bidders for the construction and



completion of “Construction of PSC Bridge No. GAD 11 over National Highway (NH-48) at MAHSR Km 241.640, Navsari district, Gujarat on Project for the Development of Mumbai-Ahmedabad High Speed Rail.” (“the Works”).

International Competitive Bidding will be conducted in accordance with JICA’s Single Stage (“Two Envelope”) Bidding Procedure.
