- 6. Tenderer may note that they are liable to be disqualified at any time during the tendering process in case any of the information furnished by them is not found to be true. The decision of NHSRCL in this regard shall be final and binding.
- 7. The validity of the offer shall be 90 days from the date of opening of the tender.
- 8. Minimum Eligibility Criteria is as under:

Should have completed at the time of opening of tender in the last three financial years (i.e. current year and three previous financial year)	At least one similar work for a minimum value of 35% of Advertised Value of work. 2. Total contract amount received during the last three financial year and in current financial year. 11.1 **RATES**:

The rates quoted by firm and accepted by NHSRCL shall be firm and final for first twelve months from the date of award of contract. For items NS1 & NS5, Petrol variation clause shall be applicable involving base standard kilometers of the vehicles. The basis for calculation of variation in Petrol prices shall be as: Petrol price variation in Rs. per km= {(New Petrol price in Rs pe ltr)-(Petrol price on date of award)}/(Mileage in km per ltr for vehicle). Mileage of Swift /Wagon R and equivalent AC petrol vehicles is considered as 12 km per litre (15 km per litre for diesel vehicle) for calculation purpose only. Mileage of Innova and equivalent diesal/ petrol AC vehicles is considered as 12 km per litre for calculation purpose only. Base Petrol price shall be taken as per actuals on the date of award. Increase/ decrease in monthly charges = Committed KMs X Petrol Price variation. If there is decrease in fuel price, formula will indicate negative which mean hire charges shall be reduced. Price variation shall be taken on 1st of every month after completion of 12 months. In case any vehicle runs on diesel, formula for esclatioon in the rates shall be same i.e. using change in price of diesal.

GST as admissible, parking charges and Toll tax charges if incurred during the onsite duty shall be reimbursed/paid on submission of documentary evidence as per applicable Rules & Provisions. Applicable taxes shall be deducted at source as per extant rules.
