Completed original tender documents sealed in an envelope super-scribing the name of work; name and address of the bidder, shall be submitted at NHSRCL's office at address in Para 1.1 above on or before 15:00 hrs. on 27.05.2019. Tender duly sealed in the prescribed manner above can also be sent through Registered Post/Courier so as to reach at the office address given in para 1.1 above **not later than 15.00 hrs. on 27.05.2019.** Any tender received later than tender closing time at NHSRCL's office at Ahmedabad shall be rejected/ unaccepted and returned to the bidder unopened. Earnest Money Deposit may be submitted in the form of Pay Order/Demand Draft/Fixed Deposit Receipt payable in favour of M/s National High Speed Rail Corporation Limited at New Delhi. Tender received without Earnest Money Deposit shall be summarily rejected.

3. Tender shall be submitted in accordance with the terms of the “Instruction to Tenderers” in the attachment hereto, which forms part of this Notice Inviting Tender.



4. National High Speed Rail Corporation Limited reserves the right to cancel the tender before submission/opening of tender, postpone the tender submission/opening date and to accept /reject any or all tenders without assigning any reasons thereof.
5. Tenderer may note that they are liable to be disqualified at any time during the tendering process in case any of the information furnished by them is not found to be true. The decision of NHSRCL in this regard shall be final and binding.
6. The validity of the offer shall be 90 days from the date of opening of the tender.
7. Minimum Eligibility Criteria is as under:

Should have done at the time of opening of tender in the last Three financial years (i.e. current year and three previous financial years).	Similar work/works for a minimum value of 35% of Advertised tender value of work.
Total contract amount received/turnover during the last three Financial years and in the Current Financial Year.	Should be a minimum of 150% of advertised Tender value, in Support of which authentic certificates shall be produced by the tenderer (s) to this effect which may be on Attested Certificate from the Employer/Client, audited balance sheet duly Certified by Chartered Account etc. should be submitted by the tenderer.

9. If the tenderer does not submit any proof of meeting the eligibility criteria as given above and Tender Conditions, along with the offer, the offer will be considered incomplete and will be summarily rejected. Certificates/Credentials issued by private individuals/Organizations shall not be accepted.
