1. **Scope of Works**

Scope of Works shall be as per Para 2 of Part I

2. **Submission of Bid Documents**

3. Evaluation of the offers received:

On scheduled date of opening of Tender offer document, Envelope-A & Envelope-B will be opened.

After finalisation of technical bids, financial bids i.e. Envelope-C of only successful eligible tenderers will be opened. The date of the same will be intimated afterwards.

In case of unsuccessful firm in either Envelope-A or Envelope-B, the sealed Envelope-C containing the Financial bid will not be opened at all, and will be returned back, treating it as invalid.

4. Mode of Payment :-

- (i) 90% of total contract value will be released upon Supply, Installation, Testing, Commissioning of truck mounted tree transplanter equipment as per specifications, to the satisfaction of NHSRCL.
- (ii) 10% of total contract value will be released after completion of training to NHSRCL personnel and after-sales support, for operation and maintenance of truck mounted transplanter equipment, to the satisfaction of NHSRCL.

5. Breakdown and Maintenance period

Normally breakdown and maintenance period should not be more than three days for which enough stock of spare parts should be maintained at site. However, in case of accidental/ major breakdown this idle period can be enhanced subject to the justification provided and acceptance by NHSRCL

6. Penalty for non-delivery within scheduled time

In an event of non-delivery, delivery of substandard equipment/services, the tender shall be held void, and the contractor (L1 bidder) shall be liable to pay NHSRCL a sum equivalent to 100% of the released contract value. Penalty will be levied up to 0.5% per week of total value of the tender for non- supply of machine/ spare parts/ services within the delivery period up 5% maximum. There after the tender will be liable to be cancelled and security deposit will be forfeited to the NHSRCL.

The tenderer should comply all the following eligibility criteria -:

- (i) The tenderer shall provide a satisfactory evidence acceptable to the NHSRCL to show that he is a licensed manufacturer, who regularly manufactures the offered Machine.
- (ii) Only OEM or OEM authorized firms/supplier, companies, consortiums having establishment in India may apply.
- (iii) Minimum annual turnover of applicant firms must not be less than Ten crores (Rs.) in last three years.
- (iv) The tenderer should have supplied atleast one set of truck mounted, fully equipped tree transplantation machine in India in last three years and the supplied machine should have worked atleast one year after supply.
- (v) The applicants must have a minimum of 2 years of relevant experience in supply and after sales support of tree transplanter machines in India.

8. Supply, installation, testing and Commissioning of the Machine

Supply, Installation, Testing and commissioning of one set of truck mounted, fully equipped, tree transplanter machine as per specifications should be completed with in 45 days from the date of issue of acceptance letter.

9. Tender Fees

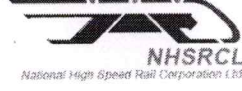

12. Performance Guarantee (P.G.)

- a) On acceptance of tender the successful tenderer shall have to submit performance guarantee amounting to 5% of the contract value in any one of the form of irrevocable Bank Guarantee or FDR from Nationalized or scheduled bank in favour of NATIONAL HIGH-SPEED RAIL CORPORATION LIMITED. The Performance Guarantee shall be submitted within 30 (thirty) days from the date of issue of Letter Of Acceptance (LOA). Extension of time for submission of PG beyond 30 (thirty) days and up to 60 days from the date of issue of LOA may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 15% per annum shall be charged for the delay beyond 30 (thirty) days, i.e. from 31st day after the date of issue of LOA.

- c) The Performance Guarantee (PG) shall be released after the physical completion of the work based on the "Completion Certificate" issued by the competent authority stating that the contractor has completed the work in all respect satisfactorily. The security deposit, however, shall be released only after passing the final bill based on "No Claim Certificate".
- d) Wherever the contract is rescinded, the security deposit shall be forfeited and the Performance Guarantee shall be encashed and the balance work shall be got done independently without risk and cost of the failed contractor, the failed contractor shall be debarred from participating in the tender for executing the balance work. If the failed contractor is JV or a partnership firm, then every member/partner of such a firm shall be debarred from the participating in the tender for the balance work either in his/her individual capacity or as a partner of any other JV/partnership firm.
- e) The NHSRCL shall not make a claim under the Performance Guarantee except for amount to which the NHSRCL is entitled under the contract (not withstanding and /or without to any other provisions in the contract agreement) in the event of:-
- (i) Failure by the contractor to extend the validity of the Performance Guarantee as describe herein above, in which event the Engineer may claim the full amount of the Performance Guarantee.

13. Training of NHSRCL Staff:

- a) Four NHSRCL personnel shall be given training for a period of two weeks in the manufacturing plant and field operation where these machines are already in operation at the cost of the supplier who shall provide facilities for the training. Likely places of training should be indicated in the offer. The cost of boarding, lodging and air fare shall be borne by the successful tenderer.
- b) Adequate training for one month of four NHSRCL personnel for the tree transplantation machine should be arranged on the bidder's premises or at the site of commissioning of machines, in the operation, repair and maintenance of these machines at no extra cost. This training of the staff to be deployed on the machine, in operation repair and maintenance shall be completed before the commissioning of the machine. The cost of boarding and lodging and travel of trainees will be borne by the successful tenderer.

14. Service Engineers

- a) The tenderer shall provide at his own cost the services of an experienced service engineer for satisfactory commissioning and operation of the machines at NHSRCL site.
 - b) Tenderers shall indicate the details of services which will be rendered for after sale service of the machines.
15. All entries in the tender should be legible and filled clearly. If the space provided for furnishing the information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No correction either in the bid document.
16.
