1. Scope of works -:

_Scope of works includes but not limited to:

- 1. Detailed design scheme preparation for shifting, diverting, removing existing plumbing utilities (open, underground & on ground) at subject location between Jetalpur Bridge(Ch396.582) to Pandya Bridge(Ch398.430) related to drainage lines (gravity & pressure), waste water line, storm water line, water line, relocation of auxiliary pumping station etc. including submission, follow-up and approval of scheme(s) from Vadodara Municipal Corporation(VMC), Traffic police, Railways, other concerned authority/agency etc.& fulfilling all the statutory requirements along with coordination with the approving and concerned statutory authorities.
- 2. Preparation of detailed cost estimate as per prevalent local Schedule of Rates, Bill of quantities, technical specifications for each type of lines including pumps etc. for shifting/diverting sewage, water etc. as required as infringing in foundation works of HSR Corridor (superstructure & superstructure works) from Jetalpur bridge to Pandya Bridge including supervision of execution of temporary & permanent works for complete period of construction by agency as deployed by NHSRCL.
- 3. Preparation of contract package & selection of contractor for execution through tender to be deployed by NHSRCL.

- 11. Location of works -: New High-Speed Railway corridor as mentioned under -: Between Jetalpur Bridge (Ch396.582) to Pandya Bridge (Ch398.430) including Vadodara station area.
- 12. Tentative drawings of the above-mentioned location's plumbing utilities are enclosed with the tender. These drawings are indicative only for references and the tenderers are advised to visit the locations for proper assessment before submitting the tender offer.
- 13. Modus operandi —: It is planned that the existing LIIVE plumbing utilities are to be diverted & or shifted (temporarily or permanently) during the construction of HSR corridor (superstructure & superstructure works) so that construction of HSR corridor can be done at designated location & after construction of HSR corridor all the utilities are reinstated at their original/ designed new location so that flow of sewage, drainage, drinking water & storm water etc by gravity or pressure in designated location is not affected in any way in all seasons at all times.

13. Key Task & responsibility:

- a. Successful tenderer shall look after all the existing utilities in the designated locations and will accordingly plan for shifting/diverting of same so that construction of HSR corridor can be done.
- b. It will be the responsibility of the bidder to ensure that the design is such that flow of existing drainage, sewerage, water & storm water line will be maintained by gravity or pressure during & after construction of HSR Corridor at designated location.
- c. Successful tenderer shall execute the work in time as per work order in full coordination with NHSRCL.

- 3. List of spares of all the equipment's to be installed at site.
- 4. All visits performed by the consultant in connection with planning, designing, detailing obtaining approval from clients as applicable including conducting visits to the officers of approving authorities, sites, office of NHSRCL. Nothing extra shall be payable on this account.
- 5. All surveys, field investigation from any specialised equipment's as directed by NHSRCL, data collections, site visits, sample collections, sample testing (with due information to NHSRCL before carrying out the activity) etc. required for the Preparation & finalisation of scheme are in scope of work of consultant and nothing extra shall be payable on this account.
- 6. The consultant shall provide 4 No. hard copies and four No. soft copies in original format for checking by NHSRCL of following documents:
 - i. Detailed project Scheme, existing as well as proposed temporary & final diversion/shifting scheme during & after construction of HSR works with all drawings in color.
- ii. Detailed design calculations of structural, electro mechanical equipment's, Pipes and other services with slope etc. complete including drawings incorporating subsequent modifications.

- iv. Detailed estimated and rate analysis of all works.

- 7. terms of the agreement. In case the agreement is terminated on account of consultant's work not being satisfactory, Department will get the work done through alternate means at the risk and cost of the consultant.

- 9. In case the consultant fails to complete the work within the contract period or extended period as above owing to reasons attributable to consultant, liquidated damages @1% per week of the total fees subject to a maximum of 10% of the total fees payable shall be levied on the consultant. Department shall be entitled to deduct such damages from the dues that may be payable to the consultant. If the work is held up at site due to no-availability of drawings/specifications/other details, penalty, proportionate to the value of the work which is held up, shall be imposed on consultant.
- 10. The Design should be strictly as per the standard guidelines as per utility owing agencies and as per the direction (if any) suggested by NHSRCL from time to time.
- 11. Vetting of Design from the competent authority as designated by the NHSRCL is the responsibility of consultant. Nothing extra shall be paid for the same.
 - 12. Soft copy in original format need to be submitted as and when asked by any stakeholders.
- 13. The consultant will be required to establish an office in Vadodara with dedicated experts as mentioned below for 3 years w.e.f date of allotment of execution of the project. The manpower to be deployed is as under

4 Responsibility for accuracy of works

The consultant shall be responsible for the accuracy of the data collected and the designs, drawings, quantities and estimates prepared by him as part of the project. He shall indemnify client against any inaccuracy in the work, which might surface out at the time of ground implementation of the project, in Such an eventuality the consultant will be responsible to correctly modify the drawings including the re investigation etc., as required.

5 Tax and other dues:

6 With holding and lien of payment.

Whether any claim or claims for payment of money arises out of or under the contract against the consultant, the NHSRCL shall be entitled to withhold and also to have a lien to retain in whole or in part, the security deposit, performance guarantee (if any) and or to withhold and have lien to retain in part or full the payments due to the consultant, are as to cover the claimed amount till the claim arising out of or under the contract is determined by the competent court.

7 Duration of works -: The Detailed design preparation has to be prepared as per the timelines mentioned in section "Time Schedule" and the duration of preparation of scheme, its approval & execution as per approved scheme with technical supervision is for 3 years from date of allotment.

8 Eligibility Criteria:

- a. The consultant must be empanelled for Design of Sewerage & Drainage Systems with Ministry of Urban Development Department, Govt. of India or with any other Ministry at the level of Govt. of India, State Govt., PWD, MES, Semi Government & other Corporations/Government Boards for Sewerage & Drainage Systems Design. Copy of Certificate to this effect may be enclosed
- b. The consultant /Firm shall have average annual financial Turnover of Rs. 100 lakhs (Rupees One Crore) every year for the last three financial years (2015-16, 2016-17&2017-18). Audited financial statements for last three years should be submitted along with the technical proposal. In case segment-wise result is not mentioned in the audited financial statement, a certificate to this effect may be enclosed from Agency's Chartered Accountant.
- c. The agency must have PAN, GST registration under applicable laws and should submit copies of the same.
- d. The agency must not have been debarred / blacklisted by any Govt. sector/PSUs/bilateral and multilateral agency for the service, ever in the past (Affidavit by the Notary of the same to be submitted by the Agency).
- e. The consultant must have completed minimum five, similar kind of works during the last ten years ending last day of month previous to the one in which applications are invited should be either of the following:


