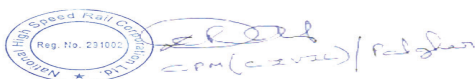

**1.1 GENERAL**

**1.1.1 Name of Work:**

National High Speed Rail Corporation Ltd. (NHSRCL) invites online open e-tenders from eligible applicants, who fulfil qualification criteria as stipulated in Clause 1.1.3 of NIT, for the work Appointment of Agency for Communication Management and Facilitation in Land Acquisition in connection with Land Acquisition for Mumbai - Ahmedabad High Speed Rail Project in Palghar District.

## 2 INTRODUCTION

### 2.1 Background

NHSRCL (the “Employer”) is implementing 508 Km long Mumbai-Ahmedabad High Speed Rail Project (hereinafter called as MAHSR Project) starting from Bandra Kurla Complex in Maharashtra and terminating at Sabarmati in Gujarat.

For supervision of project works, five site offices have been established at Mumbai, Palghar, Vadodara Surat and Ahmedabad headed by Chief Project Manager (CPM).

NHSRCL intends to appoint an agency for Communication Management and Facilitation in Land Acquisition for Palghar district which is having length of 108 KM of MAHSR to handle communication with various stakeholders like land owners, government officials, people’s representatives, opinion makers, media, etc. which need to be communicated properly about the project on a regular basis.

The Agency/Consultant shall perform the activities in accordance with the Terms of Reference (the “TOR”)

### 2.2 Request for Proposals

NHSRCL invites proposals (the “Proposals”) for selection of Communication Planning and Public Relations Management Agency (hereinafter referred as the “Agency” or “Consultant”) for scope of services in conformity with the TOR (collectively the “Consultancy”).

NHSRCL intends to select the Agency through an open competitive bidding process in accordance with the procedure set out herein.

### 2.3 Due diligence by Bidders

Bidders are encouraged to inform themselves fully about the assignment and the local conditions before submitting the Proposal and have site visit, sending written queries to the NHSRCL, and attending a Pre-bid Meeting on the date and time specified in Clause 1, NIT.

### 2.4 Sale of Tender Document

Tender document can be purchased from the NHSRCL office at the address mentioned from Date 14.05.2024 10.00 hrs to Date 05.06.2024 hrs 15.00 Hrs. Bidding documents can also be downloaded from website <http://www.nhsrcl.in>. and from Govt e-procurement portal (CPP) viz, <https://etenders.gov.in/eprocure/app>.

### 2.5 Validity of the Proposal

The Proposal shall be valid for a period of not less than 90 days from the date of submission of tender.

### 2.6 Brief description of the Selection Process

The Employer has adopted a two stage selection process (collectively the “Selection Process”) for evaluating the Proposals comprising of technical bids and financial bids to be submitted online by the Applicant. The selection will be done through QCBS (Quality and Cost Based Selection) process with 70 weightages to technical proposal and 30 weightages to financial proposal. In

the first stage, a technical evaluation will be carried out. Based on this technical evaluation, a list of short-listed applicants shall be prepared. In the second stage, a financial evaluation will be carried out. Proposals will finally be ranked according to their combined technical and financial scores. The first ranked Applicant (the "Selected Applicant") shall be called for negotiation, if necessary.

## 2.7 **Pre-Bid Meeting**

The date, time and venue of Pre-Bid Meeting shall be:

An online Pre-Bid meeting through Video Conferencing to clarify bidder's issues will be held as per details given in Notice Inviting Tender. Interested eligible Bidders, who have either purchased the Bidding Documents beforehand or the bidders eligible for exemption of tender document cost (as per tender conditions like MSME, Startup India), will be invited to attend the meeting, provided bidder submits a request along with the proof of payment of tender document cost submission/Credential for tender document cost exemption as above, through email at [cpmpalghar@nhsrcl.in](mailto:cpmpalghar@nhsrcl.in) by NIT's Pre bid Meeting date up to 11:00 hrs. Login credentials shall be provided to interested eligible Bidders through email.

The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.

The tenderer is requested to submit any question in writing through e-tender portal only (no query will be considered if received other than e-procurement portal), to reach the Employer not later than the last date of seeking clarification as mentioned in key details of NIT.

The text of the questions raised by all the tenderer and the responses given will be transmitted through e-tender portal within date specified in NIT. Any modification of the Tender Documents which may become necessary as a result of the Pre-Bid meeting shall be made by the Employer exclusively through the issue of an Addendum.

Non-attendance at the Pre-Tender meeting will not be a cause for disqualification of a Tenderer.

## 2.8 **Pre-Proposal visit to the Site**

Bidders are advised to visit the site and collect necessary information from site prior to submission of the tender. For this purpose, they will provide at least two days' notice to the Engineer in Charge.
